ACEC/MO President's Report

This week, the Missouri legislature convened for both veto session and a special session called by the Governor to address agricultural tax credits and a proposed tax cut. Ultimately, both bills were passed. The tax cut bill reduces the top tax rate to 4.95 percent in 2023 and adds four future reductions, triggered by revenue growth. When fully implemented, the top tax rate would be 4.5 percent. The Legislative Oversight fiscal note states that the legislation will reduce state revenue by \$335 million more in 2023 by accelerating a current tax cut already on the books. When fully implemented, the bill would cut taxes \$371 million a year more than the cuts already mandated by state law.



While the bills were not considered as they are outside of the scope of the call for a special session, Senator Mike Moon introduced 2 bills. The first would have repealed SB262. The second would have repealed the prohibition on trucks over 26,000 pounds from applying for the SB262 rebate. While these bills had zero chance of passing this time, it's indicative of the attitude that still remains with some elected officials regarding the increase in the gas tax.

Based upon feedback from our Business Practices Seminar Survey, ACEC/MO will be hosting a webinar on October 21st with guest <u>Jeff Gross from Gro-Nova</u>. Since my time here at ACEC Missouri, I have had multiple questions on Political Action Committees and their role here at ACEC/MO. What is a PAC? The Missouri Department of Natural Resources hereby places the Southwind Trail Subdivision Phases 2-5 Variance CWC-V-2-22 on public notice.

On the basis of preliminary staff review and the application of applicable state and federal regulations, the Missouri Department of Natural Resources, as administrative agent for the Missouri Clean Water Commission, proposes to recommend approval of the Southwind Trail Subdivision Phases 2-5 Variance CWC-V-2-22. The proposed recommendation is tentative pending public comment.

Comments should be confined to the issues relating to the proposed action and the potential effect on emergency operations and water quality.
