ACTION ALERT: Grassroots Action to Support House Passage of Bipartisan Infrastructure Investment Package

ACEC member action is needed to support final passage of the Infrastructure
Investment and Jobs Act by the U.S. House of Representatives. A vote is scheduled
for September 27. The five-year bill provides a total of \$1.2 trillion -- including \$550
billion in new investments – to support a broad range of critical infrastructure programs, including
transportation, energy, water, and broadband deployment.



The Senate cleared the bipartisan legislation on a 69-30 vote. We need the House to pass the bill and send it to the President to sign into law. ACEC and our coalition partners in the business community, infrastructure stakeholders, and construction trade unions are mobilizing a final grassroots campaign to ensure enactment of this historic bill.

EJCDC Releases New, 2021 Construction Manager as Advisor Series Documents

The Engineers Joint Contract Documents Committee (EJCDC®) today released the EJCDC® 2021 Construction Manager as Advisor Series. This series is completely new to EJCDC. The EJCDC® 2021 Construction Manager as Advisor Series (CM as Advisor Series) is intended for projects



in which the Owner's primary representative during construction will be the Construction Manager as Advisor (CM). As such the CM as Advisor Series is an alternative to the use of the EJCDC Construction Series, in which the Engineer that prepared the design subsequently serves as the Owner's construction contract administrator. The CM as Advisor Series is comprised of contract documents, administrative forms, bonds, bidding and procurement documents.

The most common and traditional framework for design-bid-build project delivery is one in which the design professional (engineer or architect) provides not only design services but also construction contract administration services as the owner's primary representative during construction. National Study on POTW Nutrient Treatment

U.S. EPA is seeking input from operators of publicly owned treatment works (POTWs) for the first phase of its National Study of Nutrient Removal and Secondary Technologies. They are currently gathering basic information on treatment technologies and wastewater characteristics at more than 16,500 POTWs nationwide.



To optimize for nutrients, many plants have made operational changes such as turning off the blowers, raising a mixer, adding brewery waste, or modifying diffusers. Share your experience with other operators. What worked and what didn't? This knowledge will help other operators make decisions that best meet plant needs.
