BIOGRAPHY

Jeff Glenn is the CEO of GlennView, a company he founded in 2010. He has an extensive history of leadership positions in government and private industry. He served as a senior staff member to United States Senator Jim Talent. He also served as Director of the Governmental Affairs Bureau for the Missouri Department of Revenue and Deputy Director of the Missouri Division of Workers' Compensation. Since 2016, while also serving as CEO of GlennView, he has also served as the Executive Director of Missourians for Transportation Investment (MFTI). He holds a Master of Public Administration degree from Southeast Missouri State University. He has been an independently certified coach, trainer, and speaker with Maxwell Leadership, a team of nearly 40,000 international coaches, trainers, and speakers, since 2014, training and coaching thousands of leaders in their efforts to grow and develop. In February 2018, he was recognized as one of sixty quarterfinalists in the John Maxwell Team Stage Time International Speaking Competition. He is also certified in the Maxwell Method of DISC and holds certifications to present programs offered by The Table Group and Empowered Living. Through his work with MFTI, he has been a leader in securing funding for transportation infrastructure around the state. Some of his successful efforts include leading campaigns to secure the passage Senate Bill 262 in 2021, which increases transportation investment by \$500 million annually in Missouri; and the passage of House Bill 4 in 2023, which includes \$2.8 billion to widen Interstate 70 to three lanes in each direction across the state, \$100 million for low-volume routes around the state, and \$50 million for rail crossing safety improvements around Missouri. Jeff volunteers his time in his local community serving as Past Chairman of the Board of Directors for the Cape Girardeau Area Chamber of Commerce. He spent nine years on the Cape Girardeau Public School District Board of Directors, where he has served three terms as President and two terms as Vice President. He also served on the City of Cape Girardeau Planning & Zoning Commission, including 2 terms as chairman. He is a member of the Cape Noon Optimist Club, having previously served as Club President. He also serves on the board of directors for Melaina's Magical Playland, an all-accessible playground, and on the Southeast Region Community Advisory Board for The Bank of Missouri. He also serves as the Treasurer for the Glenn Family Foundation, a 501(c)(3) he organized with his wife and other family members. Jeff and his wife Tracey have been married for 28 years and are partners in GlennView. They reside in Cape Girardeau. They have two sons, Zac who is a state-recognized vocalist and graduate of Lindenwood University with a degree in Music Business, and Josh, who is a state-champion swimmer and current junior at the Missouri University of Science & Technology, majoring in Chemistry.
